NSC members must belong to the National Apartment Association by joining directly or by joining a state or local apartment association.

All applications are subject to NAA Board approval and must be accompanied by \$1,700 annual dues.

Terms & Conditions

NSC yearly membership begins in January and ends in December at \$1,700 per year. NSC members joining mid-year (any month other than January) shall pay the remaining annual dues on a pro rata basis and commit to making the \$1700 annual payment for the following year to maintain membership in the National Suppliers Council. The NSC Member can decide to either: Pay the prorated amount at the start of their membership and agree to pay the \$1,700 on January 1st or Pay the prorated amount plus the \$1,700 prior to start of their membership. If the NSC Member pays the prorated amount and does not pay the \$1,700 on January 1st, when attempting to renew membership again mid-year the member must pay the prorated amount they missed during that period. Payment for prorated rate is due 30 days after invoice is sent.
